# 2025 AFCPE Symposium Scholarships

### Eligibility

To be eligible for a Symposium Scholarship applicants must be ONE of the following:

• First Time Attendee

AFCPE\*

- Student (full time or part- time)
- Financial Coach or Financial Counselor or Educator serving or committed to serving a Community Based Organization
- Financial Coach or Financial Counselor or Educator serving or committed to serving the military community
- Current or graduated FINRA Foundation Fellow
- Coast Guard Spouse, Cost Guard Veteran
- Experiencing a financial hardship that would otherwise present in-person attendance


#### And must not

- Receive any organization support or reimbursement to attend Symposium
- Be registered for Symposium at the time of application award and acceptance
- Have not received, accepted or utilized a Symposium scholarship award in the past twelve (12) months.

## **Application Questions:**

- 1. Employment and Professional areas of work
- 2. Identify additional certifications you as an applicant currently hold in good standing.
- 3. Demographic information

- 5. Will this be the first time you have attended the AFCPE Symposium?
- 6. Have you previously received a scholarship to attend Symposium?
- 7. Are you a current AFCPE Member (Membership does not impact scholarship eligibility.

Current or Graduated FINRA Fellows will be required to answer the following application questions:

- 1. Are you a FINRA Foundation Fellow?
- 2. Are you a Registered Investment Advisor/Professional?
- 3. Please note: FINRA Foundation Military Spouse Fellows who are also registered investment advisors/professionals are no longer eligible to receive a FINRA Foundation scholarship to attend the AFCPE Annual Symposium. Applicant must acknowledge understanding of the above statement.

Military Connected Counselors will be required to answer the following application questions:


- 1. Are you currently providing financial counseling or education services to service members and their families?
- 2. Please indicate the branch(es) for which you are currently providing financial counseling or education.
- 3. Please tell us the name of the military installation where you work or the name of the community where you assist Guard or Reserve Members. (Optional)
- 4. Please indicate the capacity in which you serve as a military financial counselor.

### 3 Essay Questions

Each Essay has a 250-word maximum for each essay answer.

- 1. How would receiving an AFCPE Symposium Scholarship help you better support those you serve and advance your work and as a financial professional? Please share specific examples of how this opportunity could positively impact your clients, organization or community.
- 2. What specific goal(s) do you hope to achieve by attending the 2025 Symposium? This could include something you hope to learn, a skill you want to
